Job Summary	As an Adult Project Worker at A Way Out, you will be an integral part of our Horizon adult service team, working collaboratively to achieve defined project outcomes, with a particular focus on accommodation. Your role will involve providing essential support to women who have experienced abuse, harm, or exploitation, focusing on their holistic well-being and facilitating their journey towards empowerment and recovery. You will be responsible for conducting initial assessments, developing interventions, case management, outreach activities, performance monitoring and ensuring the safety and well-being of service users. You will promote a harm reduction approach which respects individual choices, whist assessing risk, offering safety planning and support. Additionally, you will actively engage with local organisations and contribute to multi-agency support efforts.
